RULES FOR PARTICIPATION

Article 1. Purpose

Article 6. Evaluation of applications

Applications will be evaluated by Le Village by CA Milano and by Sebino management.

Article 7. Elements subject to evaluation

The criteria used for evaluating the startups are:

- **Innovativeness** of the solution.
- **Compliance** with the EU antifire current regulations
- **Readiness of the proposed solution:** development phase of the service or technology
- **Easy integration** of the solution in Sebino's services and technologies.
- **Intellectual property** of the product/service.
- **Relevant qualifications / technological certifications achieved by the team or the company.**
- **Business use cases** in the antifire and security sector.
- **Repeatability and scalability:** the ability of the business to expand.
- **Economics:** business sustainability, profitability or potential for success and for expected returns.

Article 8. Protection of privacy and confidentiality

The interested parties, by submitting their application, give their consent to the processing of their personal data. Le Village by CA Milano is the owner of the data collected.
